The math in Paragraph 4 is inconsistent.

IRS claim #1 filed 12/3/2025 shows unfiled tax returns for the years 2022-2024 and reflects a priority claim amount of \$12,739.91. Trustee has not received a copy of the 2022-2024 tax returns. Plan fails to provide any treatment for the IRS.

Plan lists a special provision in Paragraph #26: Debtor asserts that several debts schedule in the petition have already been tendered, cured, or satisfied by lawful negotiable instruments in accordance with: UCC section 3-603, 3-310, 1-303; 15 USD section 1692g(b); 31 USC section 5118; Public Law 73-10. Debtor tendered multiple negotiable instruments, including a \$500,000 Master Discharge Instrument, to settle the alleged obligations of various creditors. Creditors failed to return, reject, or dishonor the tenders, thereby discharging the obligations under commercial law. Debtor reserves all rights to pursue a Motion to Determine Validity of Tender and Securitization Fraud relating to Freedom Mortgage, whose claim is disputed due to securitization into a GNMA REMIC Trust verified via Bloomberg data. Plan payments of \$400/month are made without waiver of any tender-based discharge arguments.

Debtor has failed to provide proof to substantiate the expenses on Schedule J.
